5.0 **PRESENTATION OF REPORT OF COMMITTEE ON EDUCATION, SCIENCE AND TECHNOLOGY ON VANDALISATION OF SOME PUBLIC SECONDARY SCHOOLS OCCASIONED BY CANCELLATION OF AUTOMATIC PROMOTION IN SECONDARY SCHOOLS:**

House received the Report of the Committee on Education, Science and Technology that paid Inspection Visit to Isale-Oyo Community High school, Oyo and Interaction held with the Ministry of Education and other stakeholders in education over vandalisation of some Public Secondary Schools occasioned by Cancellation of Automatic Promotion in Secondary Schools as presented by the Chairman Hon. A.A. Adeleke (Iseyin/Itesiwaju)

Motion made "that the House do receive the Report as presented for debate" – Hon. K.H. Subair, Ibadan (Ibadan South-West I), Majority Leader.

**Resolved:** accordingly as follows, "that

- (i) The Divisional Police Officer (DPO) at Divisional Police Station, Atiba Local Government should be commended for prompt interventions that curtailed further escalation of vandalisation of schools at Isale Oyo Community.
- (ii) all erring students involved in the burning and vandalisation of Government properties should be punished accordingly to serve as deterrent to others;
- (iii) the parents should be urged to take parental care of their wards very serious at all time by sensitizing them more on the implications of moral decadence and danger of poses to the society;
- (iv) the Ministry of Education should resuscitate the Guidance and Counseling Unit and make it functional at all Public Primary and Secondary Schools.
- (v) The Ministry of Education should involve all relevant stakeholders in any serious education policy process right from inception.
- (vi) The Ministry of Education should constitute a Committee comprising of seasoned educationist to understudy states that are excelling in External examination as a way of learning from them;
- (vii) The Ministry of Education should adopt a gradual process in the implementation of the policy and the Parents, ANCOPSS, NUT, NAPTAN should accept the

- plan B as announced by the Government in the interest of progressive education in the state; and
- (viii) The governing Board of each school be constitution to comprise Students, Parents Government, Community Leader and Principal as Secretary.
