Mr. Speaker read the Contents of a letter with Ref No: GOV/2015/05/113 dated 22<sup>nd</sup> June, 2016 authored by His Excellency, Senator Abiola Ajimobi titled, "Request For The House Resolution on State's Request For Budget Support Facility". The letter stated that in view of the current fiscal situation of the State and acting on the advice of the National Economic Council (NEC), the State Government has applied for Budget Support Facility worth of Fourteen Billion One Hundred Sixty Million Naira (#14.16billion) from the Federal Ministry of Finance. The fund would be made available in three (3) tranches of #1.39billion for three (3) months, followed by #1.11billion for another nine (9) months.
