



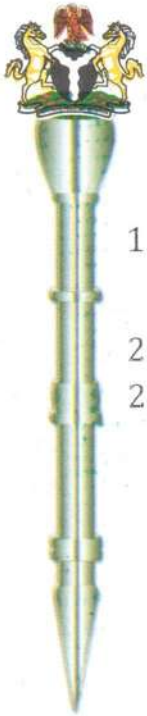

(i) OYO STATE MEDIATION CENTRE (AMENDMENT) BILL, 2016

6.0 NEED TO ENCOURAGE DEVELOPERS TO DO RECORD COPY SURVEY PLAN SO AS TO BOOST THE STATE'S INTERNALLY GENERATED REVENUE (IGR)

Motion made "That this Honourable House takes a critical look at the way and manner survey activities are carried on by unprofessional bodies with its adverse effect on the State and sensitize and encourage Corporate bodies, groups and individual developers to engage professional Surveyors for proper mapping and record of Survey Plans" - Hon. J.O. Ojo (Oriire), Minority Leader, Hon. A.A. Oladipo (Ibadan North West) and Hon. M.A. Sangodipe (Saki East/Atisbo) - Co- Sponsor

Motion seconded by Hon. G.J. Oyekola (Atiba).

Question that the Motion be debated put and agreed to.

Debate Arising.

Amendment made to the Heading thus: "Need to Compel Developers To Do Record Copy Survey Plan So As to Boost the State Internally Generated Revenue (I.G.R.)".

By leave of the House, the Motion was referred to the Committee on Lands, Housing and Survey to meet with the Ministry of Lands, Housing and Survey with a view to getting their opinions and possibly come up with a Bill to amend the Survey Law, 2013.

7.0 NEED TO RESUSCITATE PRIZE GIVING DAY AND RECOGNITION OF OUTSTANDING STUDENTS IN PUBLIC SCHOOLS IN THE STATE

Motion made "That This Honourable House show concern for the low academic performance of Students of Public Secondary Schools and deliberate on some motivational measures that will enhance their performance, such as organizing Prize Giving Day" - Hon. J. A. Olaleru (Kajola), Deputy Chief Whip.

Motion seconded by Hon. S.O. Ajanaku (Ibadan South-West II), Chairman, Parliamentary Council.

Question that the Motion be debated put and agreed to.

Debate Arising.

The title of the Motion amended thus "Need to Resuscitate Prize Giving Day and Recognition of Outstanding Students In Public Schools in Oyo State"

Question put and agreed to

Resolved as follows, "That the Honourable House:

- (1) Urge the Executive Arm of Government through the Ministry of Education, Science and Technology and Schools' Governing Board:
 - (a) to mandate Public Primary and Secondary Schools to organize Prize Giving Day where best Students in the Overall Examination and each Subject at the end of the Session will be given award/prize;
 - (b) to award Scholarship for the best Student in the terminal class for tertiary education.
- (2) Appeal to the Corporate Organisation NGO, Patriotic Nigerians, P.T.A. and Alumni Associations of various Schools to donate items generously for the Prize Giving Day in order to complement the effort of the Government;
- (3) mandate House Committee on Education to closely monitor the implementation of the resolution.
