(i) **OYO STATE TENANCY BILL, 2016:**

Motion made and question proposed, "That A Bill For A Law to Regulate Obligations Under Tenancy Agreements And the Relationship Between the Landlord and the Tenant Including the Procedure for the Recovery of Premises and For Other Connected Purposes" be read the **SECOND TIME** - Hon. K. H. Subair (Ibadan South-West I), Majority Leader.

Bill accordingly read the Second Time and referred to the Joint Committee on Justice and Judiciary and Lands, Housing and Survey for further scrutiny and report back to the House within one month.

(ii) **OYO STATE FIRE SERVICES (AMENDMENT), BILL, 2016**

Motion made and question proposed "That A Bill For A Law To Amend The Fire Services Law, 1960 be read a **SECOND TIME** Hon. K. H. Subair (Ibadan South-West I), Majority Leader.

Motion seconded by Hon. J.O. Ojo (Oriire).

Bill accordingly read the Second Time and referred to the Committee on Works and Transport for further scrutiny and report back to the House within three weeks.

7.0 **NEED TO RECONSTRUCT THE OLD KISI - IGBOHO RIAD**

Motion made, "That this Honourable House critically examine the dilapidated state of the Old Kisi - Igboho Road with a view to appealing to the Executive Arm of Government to reconstruct the road in order to boost agricultural production in the area and ensure food security in the State - Hon. Abdul-Ganiyu Oseni (Irepo/Olorunsogo)

Motion seconded by Hon. L.O. Balogun, (Oorelope)

By leave of the House, an amendment was made on the title of the Motion to read thus: "Need to Rehabilitate Major Roads in our Rural Areas, especially, the Old Kisi - Igboho Road"

Question that the Motion be debated put and agreed to.

Question put and agreed to.

Resolved: accordingly as follows, "That

- (i) the Executive Arm of Government through the Ministry of Works and Transport be urged to give priority to the rehabilitation of major roads in our rural areas, especially, the Old Kisi - Igboho Road in order to ease transportation and boost agricultural production in Irepo and Oorelope Local Government; and
- (ii) the sponsor of the Motion, Hon. A. Oseni should liaise with the Commissioner, Ministry of Works and Transport to ensure the facilitation of the rehabilitation of the Old Kisi - Igboho Road
