6.0. **MATTERS OF URGENT PUBLIC IMPORTANCE:**

(1) Pursuant to Order VIII (4) of the Standing Rules of the Oyo State House of Assembly, Hon. (Mrs.) B.O. Oladeji (Ogbomoso North) presented A Matter of Urgent Public Importance titled “Urgent Need To Avert Another Indefinite Industrial Action At Ladoke Akintola University Of Technology, Ogbomoso” Motion made that Order VIII (4) of the Standing Rules of the Oyo State House of Assembly be suspended to enable the House debate the Matter this day - Hon. A. F. Adesina (Ibadan South-East I).

The House consequently resolved as follows, that this Honourable House:

(i) urge the Governors of Oyo and Osun States to as a matter of urgency take proactive steps on the Report submitted by the Technical Committee, ensure the outstanding salaries of the Staff of LAUTECH are paid and the industrial action embarked upon by the Workers Union called off;

(ii) invite the:

(a) Commissioner and Permanent Secretary, Ministry of Education, Science and Technology;

(b) The Vice Chancellor LAUTECH Ogbomoso and other Stakeholders,

to a meeting with Committee on Education, Science and Technology with a view to making clarifications on the actual indebtedness of the two owner states and suggest possible means of getting out of the woods.

(2) Pursuant to Order VIII (4) (1) of the Standing Rules of the Oyo State House of Assembly, Hon. O.O. Olaleye (Ibadan North II) presented A Matter of Urgent Public Importance titled “Road Destruction Across the State and Urgent Need to Rehabilitate the Roads”.

By Mr. Speaker’s Order, the matter was referred to the Committee on Works and Transports to be considered with similar issue handled by the Committee and report to the House on Tuesday, 16th May, 2017.
