- (i) Pursuant to Order VIII Rule (4) of the Standing Rules of the Oyo State House of Assembly, Hon. Joshua Oyebamiji (Akinyele I) raise a Matter of Urgent Public Importance titled "Need To Expedite Action On The Rehabilitation Of Moniya – Iseyin Road To Prevent Accident On The Road". He drew the attention of the House to a ghastly motor accident of 04/11/2017 which claimed lives and destroyed properties at Moniya. He therefore, appealed for the completion of the rehabilitation of the road. By leave of the House, the Matter was referred to the Committee on Works and Transport and Committee on Local Government, Chieftaincy Matters and State Honours for prompt action.
