**3.0 APPROVAL OF VOTES AND PROCEEDINGS:**

Mr. Speaker announced that he had examined the Votes and Proceedings of Thursday, 3<sup>rd</sup> May, 2018 and called for comments.

**5.0 ANNOUNCEMENT:**

Mr. Speaker urged various Committees handling various assignments to expedite action on them with a view to consider their reports at the Plenary as soon as possible.

## 6.0 CORRESPONDENCE:

Mr. Speaker read the content of a correspondence received from the Estate of late Hon. Olalekan Asimiyu Ganiyu, the former Honourable Member representing Oluyole State Constituency dated 14<sup>th</sup> May, 2018 and signed by Architect Salaam Azeez titled "Notification of the Death of Hon. Olalekan Asimiyu Ganiyu" former Chief Whip of Oyo State House of Assembly from 2007 to 2011. The correspondence stated that the incident occurred on Saturday, 12<sup>th</sup> May, 2018 and he was laid to rest on Sunday, 13<sup>th</sup> May, 2018 according to Islamic rites. The 8<sup>th</sup> day fidau prayer would hold on Sunday, 20<sup>th</sup> May, 2018. The Committee on Special Duties and the Honourable Member representing Oluyole State Constituency, Hon. M.A. Wahab were directed to liaise with the family as the representative of the House at the 8<sup>th</sup> Day Fidau prayer.

## 7.0 ELECTION OF A NEW SPEAKER:

The Clerk called for other nomination and in the absence of any other nomination, Hon. J.O. Ojo was declared as the new Speaker-elect of the 8<sup>th</sup> Assembly.

#### **8.0 OATH OF ALLEGIANCE:**

Pursuant to Order II, Rule 2(5) of the Standing Rules of the Oyo State House of Assembly, Hon. J.O. Ojo (Oriire), Speaker took Oath of Allegiance and the Oath of Office as the Speaker of the Oyo State House of Assembly.

#### **9.0 ACCEPTANCE SPEECH OF THE NEW SPEAKER:**

Rt. Hon. J.O. Ojo, the newly elected Speaker gave thanks to Almighty God for making his emergence possible. He reflected on the unfortunate incidence of the demise of the late Speaker, Hon. Michael Adesina Adeyemo. He thanked his colleagues for his nomination. He appreciated His Excellency, the Governor of Oyo State for providing enabling environment for the Legislature – Executive relation. He therefore, called for the cooperation of his colleagues during his Speakership.

#### **10.0 ELECTION OF OFFICE OF NEW MINORITY LEADER:**

Sequel to the election of Hon. J.O. Ojo (Oriire) as the new Speaker , the position of the Minority Leader was declared vacant.

Mr. Speaker called for nominations into the vacant post of Minority Leader .

Motion made, “that Hon. Akeem Ademola Ige (Ibadan South-East II) be nominated as Minority Leader – Hon. O.S. Akande (Ogbomoso South).

Motion seconded by Hon. O.A. Oyatokun (Afijio).

Mr. Speaker called for other nominations but in the absence of none, Hon. Akeem Ademola Ige (Ibadan South-East II) was declared the new Minority Leader of the 8<sup>th</sup> Assembly.
