- 2.0 the Joint Committee on Works and Transport and Health would meet after the Sitting to deliberate on Road Traffic Management (Amendment) Bill, 2018; and
- 3.0 the Joint Committee on Local Governments, Chieftaincy Matters and State Honours and Establishments, Training and Poverty Alleviation would meet in the Caucus Room after the Sitting at 1.00 p.m. to consider State Joint Local Government Accounts (Distribution) (Further Amendment), Bill, 2018.

7.0 REPORT OF CONFERENCE AND SEMINARS

The Report of a Training Programme organized By KONRAD ADENAUER STIFTUNG (KAS) On 2019 General Elections – The Roles and Functions of Legislature and Executive Arm in Pre-Election Year held at Obudu Cattle Ranch, Cross River State From Monday, 19th to Thursday, 22nd March, 2018 was presented by Hon. A. Musah (Saki-West), Deputy Speaker.

Motion made, “That the House do adopt the Report as presented for debate” – Hon. K.H Subair (Ibadan SouthWest I), Majority Leader.

Motion seconded by Hon. A.A. Ige (Ibadan South-East II), Minority Leader.

Debate Arising.

Question, that the recommendations contained in the Report be adopted put and agreed to.

Resolved accordingly as follows “that:

- (i) Honourable Members of the 8th Oyo State House of Assembly be commended for pro-activeness in the passage of laws that strengthen the Legislature (for instance, Oyo State House of Assembly Self Accounting Law, 2017) and Members be urged not to relent in legislative activism by facilitating the passage of more laws that will engender the full autonomy of the Legislature;
- (ii) the Standing Committees of the House be further strengthened with requisite manpower and logistics with a view to facilitating efficient and effective tracking of the Budget through oversight activities;
- (iii) the House submit Report on Training and Interactions with Konard Adenaurer Stiftung (KAS) with a view of appreciating KAS for its invaluable contribution to the Nigerian nascent democratic process;
- (iv) the National Orientation Agency (NOA) and information disseminating Ministries, Departments and Agencies of Oyo State Government to:

- (a) intensify political education at all levels towards sensitizing politicians and their agents on the need to practice principled politics and politicking in the forthcoming 2019 elections;
- (b) urge candidates aspiring for elective posts in the 2019 elections to practice goodwill, exercise strong discretion in cross carpeting, eshow violence, hate speech and luring electorates with pecuniary benefits, this is with a view to facilitating credible democratic process; and
- (v) the Executive Arm of Government through the Office of the Governor be urged of facilitate quarterly or bi-yearly (or as the need arises), Executive/Legislative Retreat with a view to further ensuring synergy, good governance and service delivery in Oyo State.
