## **5.0 PERSONAL EXPLANATIONS:**

(i) Hon. G.J. Oyekola (Atiba) with heavy heart announced the demise of former Member of the Assembly. Late Hon. Waliu Adekunle Ganiyu (a.k.a Ere Oyo) who died on Monday, 30<sup>th</sup> October, 2017. He was born on 17<sup>th</sup> May, 1972. He obtained his first Degree Certificate from the University of Ado-Ekiti in 2005 and later proceeded to University of Ibadan for his Masters Degree in 2014.

Hon. Waliu Ganiyu represented Atiba State Constituency in the 7<sup>th</sup> Assembly. He was the Chairman, Committee on Works and Transport and Member of many other Committees. He was a grassroot politician and served as Supervisory Councillor for Education at Atiba Local Government from 1993 - 2002. He contributed immensely to the socio-political growth and development of Atiba Local Government and the State in general. While concluding his statement, Hon. Oyekola (Atiba) prayed that God will grant the family the fortitude to bear the irreparable loss.

(ii) Hon. O.O. Olaleye (Ibadan North II) also paid tribute to late Hon. Waliu Adekunle Ganiyu. He made particular reference to the unprecedented achievements of late Honourable during his school days and his immense contributions as a team player in the 7<sup>th</sup> Oyo State House of Assembly. He expressed with deep heart condolence to the wife and children as well as family of the deceased left behind. He concluded by praying for his soul to rest in peace.

(iii) Hon. Abdulwasi Musah (Saki West), Deputy Speaker also expressed deep sympathy on the demise of the son of the A.P.C. National Leader and Chieftain, Senator Ahmed Bola Tinubu. The sad event occurred on Tuesday, 31<sup>st</sup> October, 2017. Jide Tinubu, a Barrister at law who was called to bar in 1999 was born in the 80s. He was an astitute legal practitioner and a lawyer of repute. He was married with 3 children. Jide Tinubu had his First Degree at the University of Liverpool where he graduated with merit, he later bagged his Post graduate Degree in Law from the University of London. He worked with TSL Limited and Mobil Producing Limited.

Hon. Musah prayed that God grant him eternal rest and the family the grit to bear the loss.
