- (b) the Committee on Health should invite the Commissioner, Permanent Secretary and other relevant schedule officers of the Ministry of Health to a meeting in the Conference Room, New Office Complex on Tuesday, 17th October, 2017 at 2.00 p.m. to discuss the health status of the State vis-à-vis the outbreak of the virus, its prevention in the State and awareness campaign to the general public and report back to the House.
